## Charities lobbying Peers to topple Rwanda plan have received £209m in government funding

The British taxpayer is being forced to fund charities that are lobbying against the Government's plans to tackle illegal immigration.

On 27 January 2024 a group of over 265 charities, civil society groups, and law offices wrote to Peers demanding that they vote down the Safety of Rwanda (Asylum and Immigration) Bill at its Second Reading.<sup>1</sup>

The groups described the Government's flagship legislation, which aims to get flights off the ground by classifying Rwanda as a 'safe' country for illegal migrants to be processes, as "a constitutionally extraordinary and deeply harmful piece of legislation."

They allege that "it threatens the universality of human rights and is likely in breach of international law, striking a serious blow to the UK's commitment to the rule of law", that it "is an attack on the constitutional role of the judiciary and the rule of law", and that "it would set a dangerous precedent for future governments."

It can now be revealed by the Centre for Migration Control that almost half of the groups who have signed this letter are in receipt of public funds, either through grants or government contracts.

## Analysis reveals that in just three years these anti-Rwanda organisations have received over £200m in public funds. (Annex A).

Amongst those groups in receipt of public funds are Freedom from Torture. In recent days the group has plastered anti-Rwanda posters over the London Underground and railed against the "cruel policies" of the government.





Despite receiving over £600,000 from the government, the group's CEO, Sonya Sceats, has previously boasted about flaunting requests from the Home Office to remove videos criticising the former Home Secretary, Suella Braverman.

A group in receipt of over £800,000 in public funds is Action Foundation. However, a large chunk of this money comes through public sector contracts, where it performs functions on behalf of the state.

However, despite working with the government in the deliverance of certain policies, it has described the Rwanda plan as "cruel and ill-thought-through".

In a self-defeating passage, the group also says that "somehow, our Government deems it OK to suggest that **young men** coming from other parts of the world can be shipped off to Africa to have their detention claims decided and, if successful, they will *not* be offered refugee status in the UK but *will* be 'allowed' to stay in Rwanda, **no matter that they wanted to make their future here**."

The emphasis has been added by CMC, to display that Action Foundation knows full-well that a) the overwhelming majority of the illegal migrants arriving in the UK are young men, not women and children, and b) that the decision to arrive in the UK was one of luxury rather than necessity. The simple desire to live in the UK is not the basis of an asylum application.

More potently, Action Foundation was the group which housed and supported the man behind the Clapham acid attack, Abdul Ezedi, during his application process for asylum in 2020/2021.
